Safeguarding: I took part in the Safeguarding Network Zoom meeting on 29th November 2023 where we were updated about new Safeguarding procedures from KCSIE. Lucy had also sent me a link to a video which I watched on 23/1/24 which also raised some questions about the updates to KCSIE. Q: Is our policy from NST exemplar? Yes. Q: The filtering and monitoring section, whose function is to keep children safe when using school IT systems, is an addition to KCSIE. Is this included in our safeguarding policy? In our IT policy? Yes, in both Safeguarding policy and e-safety policy. Q: What filtering and monitoring arrangements are in place? In above policies. Smoothwall Monitor in use. Alerts staff to child's attempt to access inappropriate material, risk-assessing everything a child types across Google, Office 365, offline documents, web chat etc. Q Was filtering and monitoring included in Safeguarding update to staff at the beginning of the school year? Yes. Q: How has school implemented the changes in KCSIE? Through updates to policy and staff training. Q: How do children know who to talk to? Ongoing theme in assemblies and through Spiritual, Moral Social and Cultural values policy. General school update: Staffing – maternity leave for 2 staff in May and June respectively. School expansion. School is settled with a good start to the new term.
