Objectives of the visit including links to school development plan:

To review the new statutory guidance for RSHE/RSE due to be implemented by September 2026:

To have a clear set of principles:

- Engagement with pupils
- Engagement and transparency with parents
- Positivity
- Careful sequencing
- Relevant and responsive
- Skilled delivery of participative education
- Whole school approach

To include new curriculum content:

- Challenge of sexism, misogyny, violence against women and girls
- How to identify positive male role models
- Ethical behaviour in relationships
- New guidance on covering LGBTQ+ topics (in compliance with Equality Act 2010)

Governors Role:

To ensure that:

- **School has up-to-date RSE policy in line with new guidance.**
- **Curriculum content and teaching materials are aligned with the statutory guidance**
- **Clear information is given to parents/carers on the subject content, teaching materials and external providers, and on the right to request their child is withdrawn from sex education.**
- **All pupils make progress in achieving the expected educational outcomes,**
- **Teaching is accessible to all pupils with SEND**

Strengths identified:

- RSHE/RSE, as part of Welbeck's bespoke PSHE curriculum, is well established and forms a vital part of the vision and aims of the school.
- From September they will also be using 'Jigsaw' to complement the existing, extensive scheme of work. Jigsaw is a national scheme which will hopefully ensure inclusion of all the new statutory elements.
- Parents are well informed about the PSHE/RSHE/RSE curriculum. It is introduced at the September Parent's meeting and subject content and teaching materials can be found on Welbeck's website in the appendix of the PSHE policy.
- SEND pupils are included in all lessons and activities that are accessible and relevant to them.

Actions for staff:

- To ensure new statutory guidelines are included in the RSHE/RSE policy.
- To present updated Policy to Governors for adopting.
- To review new Jigsaw scheme of work and ensure new statutory guidelines are included.
- To make parents aware of the new statutory content.
- To ensure all pupils make progress in achieving the expected educational outcomes,
- To continue to ensure RSHE lessons are accessible to SEND pupils.

Actions for Governors:

- Read and adopt updated policy.
- For GD to familiarise herself with Jigsaw scheme.

Evaluation of visit:

It is clear that RSHE/RSE is seen as an important and valuable part of Welbeck's ethos and provision for all its pupils.

Pupils and parent's views are valued and their feelings always considered in this sometimes sensitive part of the curriculum.
